# Letter from the Secretary General

Dear Fellow-members of the IAHR,

This issue of the IAHR Bulletin comes to you fairly soon after the first issue in order to make available the list of officers of member associations which was requested from various quarters. Alas, difficulty has been experienced in corresponding with certain countries, but every effort will be made to ascertain up-to-date information about our affiliated associations. Assistance would be much appreciated.

Another important item in this issue is the text of the constitution of the IAHR. This has, of course, been published before, but it may be helpful to record again the precise text. It has been observed that this text is not quite without problems. These are mainly points of presentation, such as the juxtaposition of the words "statutes" and "constitution" in the heading. However two points of substance have become apparent in the recent experience of the IAHR and it may be necessary to prepare minor amendments in good time for the 1990 Congress. These points are the final sentence of Article 4 C (which, had it not been for the moderation and good sense of those present, might have led to a constitutional impasse at Sydney) and the lack of all reference to a quorum for the official meetings. I would be grateful to receive the views of any IAHR members, and especially committee members, on these points.

#### CONFERENCES

#### BAHR Annual Conference 1986

16-18 September 1986, Cherwell Centre, Oxford.

For this year's conference we are returning to the idea of a conference theme, and the theme agreed upon at the last AGM was 'Official and Popular Religion'. This distinction, sometimes known as the distinction between the 'learned' and the 'popular', is closely related to the distinction drawn between the 'great' and 'little' traditions and is also pertinent to questions about what is 'classical' ('typical' or 'normative') in religions. The official/popular distinction will be explored as it applies (or fails to apply) to various religious traditions, and it is hoped that the papers and the discussions they generate will cumulatively contribute to some overall assessment of the theme in question.

In addition to full-length papers there will be room for some shorter papers (c. 20 minutes) and, as is our custom, for brief reports (10 minutes) on research in progress. Already we have some firm offers of papers: Dr. Hilda Ellis Davidson (Cambridge) on 'Pagan imagery against a Christian background in Iceland and Ireland'; Dr. Martin Southwold (Manchester) on Theravada Buddhism; and Dr. Douglas Davies (Nottingham) on 'Dual ritual: the varied outcome of popular and official religious intention'. Also, Dr. J.L. Brockington (Edinburgh) has provisionally agreed to contribute something on the Hindu Puranas. A conference programme should be ready by the next issue of this Bulletin. Meanwhile members interested in contributing a paper or report are invited to write direct to the conference organizer, Dr. Peter Moore (Darwin College, The University of Kent, Canterbury), as soon as possible. During the 11th ICAES, which was held in Canada in 1983, the Permanent Council of the International Union of Anthropological and Ethnological Sciences (IUAES) elected Prof. Dr. Hubert Maver (Zagreb) as its President. He will serve in this capacity until 1988. At the same meeting, the decision was made to hold the 12th Congress in Yugoslavia, in Zagreb.

The 12th Congress is being organized under the working title of "World Anthropology: Education, Research, and Application". The proceedings of the Congress will consist of: (1) plenary sessions; (2) meetings of special IUAES Commissions; (3) symposia; (4) poster sessions; (5) exhibitions; (6) film sessions, as well as other activities to be offered by the Organizational Committee.

<u>Plenary sessions</u> will enable the presentation of various viewpoints having to do with the current position and role of anthropological and ethnological science in human society. All Congress participants will have the opportunity to participate in discussions during Plenary sessions, as a means for formulating new strategies for developments in the profession throughout the rest of the twentieth century.

Symposia activities will permit extensive review of current work in the field from the perspective of the different sub-fields of anthropology and ethnology. Approximately 150 symposia will constitute a major core of the meeting proceedings. While we strongly urge prospective Congress participants to develop entire sessions, incorporating established and new scholars into coherent overall symposia, we will also accept individual volunteered papers. These papers will be incorporated into existing symposia, or organized into sessions of their own, depending upon their content.

#### STATUTES

#### CONSTITUTION

as accepted and confirmed by the General Assembly of the IAHR at its XIIth International Congress, held in Stockholm, on August 22nd, 1970, and amended by the General Assembly at the XIIIth International Congress, held in Lancaster, on August 22nd, 1975.

Article 1 - The International Association for the History of Religions (abbreviated, from its English title, to IAHR), founded in September, 1950 on the occasion of the 7th International History of Religions Congress, is a world-wide organization which has as its object the promotion of the academic study of the history of religions through the international collaboration of all scholars whose research has a bearing on the subject.

# Article 2 - The IAHR seeks to achieve this object:

- by holding regular international congresses and occasional symposia and colloquia;
- 2) by publishing the proceedings of such congresses and meetings;
- 3) by assisting the formation of national and regional associations of historians of religions;
- 4) by encouraging and sponsoring publications of general interest to the study of the history of religions; e.g. an international review, bibliographical bulletins, monograph series;
- 5) by taking all appropriate steps to encourage and further the academic study of the history of religions.

#### Article 3 -

- A) The IAHR is constituted by national or multi-national (regional) societies for the academic study of religions. These are such societies as are now members and such societies as apply for membership and, on recommendation of the Executive and International Committees (see below), may be admitted by the General Assembly at future International Congresses.
- B) To the IAHR may be affiliated:
- International associations for the academic study of particular areas within the history of religions;
- Individual scholars for whom there is no appropriate national or regional society.

Affiliation is effected by the application to the Executive and International Committees and by approval of the General Assembly.

Article 4 - The work of the IAHR is carried out through (a) the General Assembly, (b) the International Committee, and (c) the Executive Committee.

A) The General Assembly of the Association meets at each international congress and is composed of all members of constituent societies of the Association present at that congress. The General Assembly may

take action only on matters referred to it from the International Committee, and it may refer any matter to the International or Executive Committees for consideration and report.

- B) The International Committee is composed of
- Two representatives each of the constituent national and regional societies except that there shall not be more than two representatives from any one country.
- 2) The Executive Committee (see below)
- Up to four individual members coopted by the International Committee on the recommendation of the Executive Committee.
- C) The Executive Committee is composed of a President, two Vice-Presidents, a General Secretary, a Treasurer, and five other members. The officers in particular, and the members of the Executive Committee in general shall be chosen in such a way as reasonably to reflect various parts of the world where academic study of religion is pursued in its various disciplines. A Nominating Committee, appointed by the Executive Committee, shall submit nominations for the next Executive Committee to the members of the International Committee by mail not more than twelve months and not less than nine months prior to each international congress. Members of the International Committee may propose alternate nominations not less than one month prior to each international congress. The International Committee, at its meeting just preceding the General Assembly shall elect the Executive Committee and shall report this to the General Assembly for endorsement.

The members of the Executive Committee shall hold office for one quinquennial term each and be subject to reelection, but not more than two-thirds of the Committe shall be carried on from one term to the next, and no one member shall serve in the same office more than two terms (with the exception of the Hon. Treasurer).

In the event of the death or resignation of any serving officer of the Association a suitable replacement may be nominated after consultation among the remaining officials, and shall serve, subject to the written approval of a majority of members of the Executive Committee, until the next quinquennial Congress.

Article 5 - The Executive Committee, or at least the President, General Secretary and Treasurer of the Association shall, if possible, meet at least once a year for the transaction of such necessary business as may rise between Congresses. The General Secretary shall circulate the minutes of such meetings to all members of the Executive Committee.

Article 6 - The International Committee shall meet on the occasion of each congress, between the meeting of the Executive Committee and that of the General Assembly, and more often if necessary. It reports to the General Assembly.

Article 7 - The resources of IAHR consist of A) annual contributions paid by the consistuent societies, affiliated societies and individual members, the amount of which is assessed by the Executive Committee, and B)

grants, donations and other sources of revenue. An audited report will be submitted to the International Committee at every International Congress.

<u>Article 8</u> - The Statutes may be modified only by the General Assembly on the recommendation of the International Committee.
