Letter from the Secretary-General

Dear fellow-members if the IAHR,

As we approach the meeting of the International Committee in Paris (September 17-21) there is still a little time left for any discussions which may seem to be necessary within our affiliated associations. May I remind you that each national affiliated association may participate with two voting members (except in one or two cases where this voting strength is shared between two organizations). Usually the president and the secretary will be representing their national association. However it is possible to designate another member instead, if finances and travels make this more convenient.

It is well understood that not all associations can be equally represented in fact, because of the cost. However at the moment there is nothing that can be done about this. The purpose of the Endowment Fund appeal is to work towards a situation in which the meetings of the Executive Committee (one meeting each year) and of the International Committee (one meeting between each quinquennial congress) can be ensured. As we have not yet reached that happy situation, I can only ask you to make every effort to send at least one, if not two delegates.

If your officers have not yet received an invitation from Paris, please communicate directly with our Vice-President, Prof. Jean Leclant, whose address is on the inside back cover of this bulletin with the other members of the Executive Committee. If there is a funding body in your country which would require an additional letter from me to emphasise the importance of your attendance at the International Committee meeting, please do not hesitate to let me know, and I will write it in the appropriate manner.

In the pages of this bulletin you will find an abbreviated version of the draft programme. As to the agenda of the International Committee meeting, it is expected that there will be a wide range of matters to discuss, especially with regard to the forward planning of the conference and publications programme. In addition, there is the important subject of the name of our association, concerning which, however, the International Committee can only "recommend". Please let me know if your national association, or if you as an officer, wish to add anything to the agenda.

The Name

The following letter has been received from Professor Peter Antes as President of the German Association for the History of Religions (DVRG):

in reply to the question concerning the name of IAHR I want to inform you that the executive committee (Vorstand) of the DVRG had a meeting in Hannover on January 29th, 1993, and discussed this issue extensively. The following decision was taken:

The DVRG will not reject the idea of a change of the name of IAHR as a matter of principle but it wants to make clear that a real improvement must be reached if a change should take place. The DVRG will not accept an unspecified use of "study", because of fear that the academic level is thus not assured, nor will it be ready to accept "religion" in the singular because of eventual confusion with Christian theology. If no real improvement is made by the new name the DVRG will opt for maintaining the present name which already has a long tradition in academic circles.

Reorganisation in Eastern Europe

Czechoslovakia / Czech and Slovak Republics

Consequent on the foundation of independent Czech and Slovak Republics with effect from January this year - there are now two Associations for the Study of Religions in this region. Since the officers of the currently affiliated association are the same as those of the successor Czech association it has been agreed that this association will continue the existing affiliation to the IAHR. The President is Prof. Jan Heller, the Secretary Dr. Dalibor Papousek and the Treasurer Dr. Iva Dolezalova. The formal change of name of this association will take place at a meeting planned for March 1993. In the meantime a Slovak Association for the Study of Religions (Slovenska spolocnost pre studium nabozenstiev) has also been founded with Prof. Jan Komorovsky (Bratislava) as President. It is expected that a request for affiliation will be received in due course.

Ukraine

A communication has been received from a colleague in Kiev, The Ukraine, Prof. Anatolij Kolodnij, to the effect that a Ukrainian Association for the Study of Religions has been founded. The intention has been signalled to apply for affiliation to the IAHR. Any communications regarding this development should be addressed, in the first instance, to the Secretary-General. it is hoped that a recommendation can be placed before the International Committee in Paris this year.

It is also planned to include seminars for research students and for those involved in the teaching of some particular field of studies. To add further variety, documentary films relevant to the conference theme will be shown at various points in the programme.

The conference also features the Annual BASR Lecture, which this year will be given by Professor Dr Ria Kloppenborg, of the University of Utrecht, who will talk on an aspect of Buddhism relevant to the conference theme.

Participants are also encouraged to bring to the conference any appropriate items for display or sale: books, leaflets, posters, details of other conferences and societies, etc.

The conference fee will be £10, accommodation will be around £20 per day, bed & breakfast, with concessions for students and the unwaged.
