Professor Ugo Bianchi

It is with the utmost regret that the following information has to be conveyed to the membership. As many will by this time have heard, our colleague and friend Professor Ugo Bianchi, President of the IAHR, died suddenly on April 14th. He suffered a heart attack. A letter has been written to Mrs. Bianchi, on behalf of the IAHR, to express the sadness and sense of loss which will be felt by colleagues throughout the world. His memory will be honoured at the opening session of the forthcoming Congress in Mexico City.

Letter from the Secretary-General

Dear Colleagues,

First of all I must express my personal sense of loss and dismay at the news indicated on the first page of this bulletin. Professor Bianchi has been a kindly friend to me for over twenty years. Over the past few months we had been conferring over the arrangements for the various formal meetings of the IAHR in Mexico. As members will be aware, Ugo Bianchi was acutely aware of the importance of some of the decisions which lie ahead of us. He will be remembered for this, whichever directions are taken for the future. His memory will of course be honoured at the Congress and also in the pages of the official organ of the IAHR, Numen.

Under the circumstances the various officers of the Executive Committee have been in touch with each other, and we will do our best to ensure that the forthcoming IAHR meetings are carried through correctly and well. This bulletin contains the agendas of the meetings. These had been approved in main outline by Professor Bianchi during recent recent communications.

Due to various practical difficulties it was not possible to produce the bulletin in January. Moreover, in view of the high postal costs of this A4 format when sent from Germany, it seemed best to await further correspondence from member associations and then to issue just one more bulletin, a short while before the Congress. This has the advantage of bringing you the agendas of the meetings. The full list of member organizations and officers will be included in the Congress issue of the bulletin. Please note that a few changes of officers were reported in the last bulletin and that a few more are listed here. The Congress issue of the bulletin will be distributed by post to association officers who are unable to attend.

On the next page you will find some important reminders about voting procedures for the International Committee and the General Assembly. The absolute closing date for all communications about the representation of your association in Mexico, matters for the agenda, etc. is <u>July 4th</u>. This is also the formal and <u>final</u> closing date for nominations for the elections to the Executive Committee. The Congress issue of the Bulletin will then be printed.

All arrangements concerning your participation in the Congress as such <u>must</u> be made through the Congress organization. I am looking forward to meeting you in Mexico.

As this is my last bulletin letter to you as Secretary-General, I would like to thank you for the great encouragement and support I have received from many quarters throughout the world. With all best wishes

Discussion on the change of name

The General Assembly will take a decision on a proposed change of name for the IAHR at its meeting on the last day of the Congress to be held in Mexico City. The International Committee, at its meeting in Paris on 19.9.1993 (c.f. Minutes in Bulletin 27, pages 5-6) passed the following resolution.

"It is recommended that the name of the IAHR be changed to "The International Association for the Academic Study of Religions" in English and "L'Association Internationale pour l'Étude Scientifique des Religions" in French."

This recommendation, being a constitutional matter, will therefore be placed before the General Assembly for decision. Voting rights and procedures will be scrupulously observed. In the meantime the discussion has been continuing. See following items.

Correspondence on this subject from Germany:

Professor Hans Kippenberg, writing as first chairman (president) of the Deutsche Vereinigung für Religionsgeschichte reports that the executive of the German association seeks the insertion of the word "Academic" before the word "Study" in the proposed change of name.

N.B. This means in effect that the executive of the DVRG has decided in favour of the wording already recommended by the International Committee at its meeting of 19.9.1993 in Paris (see above).

Correspondence on this subject from Canada:

Professor Jordan Paper, treasurer of the Canadian Society for the Study of Religion / La Société Canadienne pour l'Étude de la Religion, writes as follows:

Dear Prof. Pye:

Prof. Bianchi's paper, reproduced in IAHR Bulletin 30, clarifying the topic of "History of Religions," provides explicit reasons for the need to change the name of our society. Outside of Europe, scholarly funding bodies understand the term in English literally -- the history of particular religions, exclusive of phenomenological, comparative and textual studies; i.e., those applying for funds to study the history of religions should be in a department of history. Moreover, these same funding bodies interpret international

associations in the same way; for example, the Social Science and Humanities Research Council of Canada only continues to fund participation in the IAHR by the Canadian Society for the Study of Religion on the understanding that the name will change to reflect an international body for the study of religion *per se*. In order to maintain the "comparative-historical character" of the discipline, a name change is essential from a pragmatic standpoint, much as nostalgia argues for a continuation of the present name.

To summarize considerations presented earlier in this regard, the consequences of failing to change of name of the IAHR to reflect the names of the vast majority of the constituent national bodies would be twofold:

1) It would create unnecessary pressures on constituent bodies incorporating the term "religious studies," both financially and with regard to recognition. This latter aspect is of particular concern to new national bodies already recognized or being organized. Were the name not to change, funding bodies may require these societies to form a new international organization that explicitly states that its concern is "religious studies."

2) If the name were not to change, there would be a perceived vacuum with regard to an international organization for religious studies. A certain very large, national body, not a part of the IAHR, may again seek to expand to become recognized as such an international organization.
