Current arrangements for Numen (item 7)

It is a matter for most satisfactory report that agreement with the publishers E. J. Brill of Leiden has been reached some time ago, and a contract signed, which among other things provides a modest but sigificant contribution towards the funding of the meetings of the Editorial Board (and hence of the Executive Committee of the IAHR). After considerable discussions about the length and phasing the appointment of Executive Editors (by the Executive Committee) it has been agreed to work towards a situation in which each Executive Editor should serve for a maximum of two five year periods. The current editors are Professor Kippenberg and Professor Lawson. Arrangements to ensure both change and continuity have been set out in a lengthy paper (dated 13.2.1995) and agreed by the Executive Committee. The arrangements envisage that a new appointment should be made every five years at a point one or two years before the main international congress. Professor Kippenberg has been reappointed (in 1994) for the period 1995 - 2000. It is to be anticipated that appointments made in 1998 or 1999, but to run for five years from 2000, would include Professor Lawson (for continuity) and a new editor. After that, Professor Lawson would drop out, and so on. The reviews section would normally be handled under the direction of the editor in a second term, as is currently the case.

Proposals for individual memberships of the IAHR (9)

The main reasons for introducing an individual "add-on" or "corresponding" membership of the IAHR are that there is a growing interest in the flow of information carried by the association and that a reasonable subscription could help to make the production of the IAHR Bulletin economically self-sufficient. At the same time the constitutional structure of representation through affiliated associations should not be changed, since it helps to ensure a relatively wide intercultural participation. With this in mind the International Committee is invited to approve the setting up of such arrangements in principle, to leave the details to the incoming Executive Committee, and to recommend appropriate adjustments to the phrasing of the constitution (see further below). This proposal comes from the Executive Committee meeting at Brno (1994).

Honorary life memberships (item 10)

It is proposed that a number of "honorary life memberships" be conferred on senior scholars who have served the IAHR by regular participation in conferences, as national or international office-holders, or in other ways. Such membership would have neither financial nor constitutional implications, but would help to designate the range of interests current in the IAHR by reference to established specialists. It would also provide a wide ring of consultants relating to publications, etc.. This proposal also comes from the Executive Committee meeting at Brno (1994).

New affiliations (item 11)

The following <u>new</u> requests have been made for affiliation to the IAHR, and if <u>recommended</u> may be put before the General Assembly during the present Congress (in addition to those already recommended):

Spain
New Zealand (if application submitted in time)

(Already recommended in Paris: African Association for the Study of Religions (regional association); India, Ukraine.)

Recommendations for changes to the Constitution (item 12)

There are two sets of changes to the Constitution which the International Committee may wish to recommend to the General Assembly. One series of changes (A) would follow from the adoption of the new name which has been proposed. The other changes (B) are related to the proposals for an additional individual membership

of the association. The two sets of changes should be voted on separately.

- (A) The International Committee recommends that, in the event of the new name being adopted by the General Assembly, the Constitution should be rephrased as necessary to take account of this change. In detail, the letters IAHR should be replaced by IAASR and the phrase "academic study of religions" should be used at the appropriate points in Articles 1, 2c, 2e, 3Ba, 4.
- (B) The International Committee recommends that Article 3B should be rephrased to read as follows:
- "(a) International associations for particular fields within the study of religions may be affiliated to the IAASR as corresponding associations without voting rights.
- (b) Individual corresponding membership of the IAASR may be arranged and maintained by the Executive Committee, always provided that these arrrangements are not disadvantageous to the constituent associations.

Affiliation and membership provided for in this article does not confer voting rights."

If the International Committee decides to recommend these two changes, they will be put before the General Assembly at its meeting in Mexico City.

Celles-ci visent l'histoire et ne conçoit pas celle-ci autrement que comme la mise en oeuvre de tous les moyens appropriés à la recherche systématique d'une image scientifiquement fondée de l'homme religieux 'en situation', le sacré étant l'une des composantes décisives de celle-ci.

Ces considérations inspirent notre attitude dans le débat autour de l'intitulé de l'IAHR. Celle-ci ferait bien de s'inspirer des travaux et de la méthodologie du regretté professeur Bianchi: puisqu'il ne peut y avoir d'histoire des religions qui ne soit par là-même scientifique, nous sommes très hostiles au changement de nom préconisé, dans la mesure où il s'agit de beaucoup plus que d'une 'étiquette', d'un changement d'approche, de méthode et de téléologie que nous n'approuvons pas.

The Constitution Of The International Association For The History Of Religions

As accepted and confirmed by the General Assembly of the IAHR at its XIIthInternational Congress held in Stockholm on August 22nd 1970 and amended by the General Assembly at the XIIIth International Congress held in Lancaster on August 22nd 1975.

ARTICLE 1

The International Association for the History of Religions (abbreviated, from its English title, to IAHR), founded in September 1950 on the occasion of the Vllth International History of Religions Congress, is a worldwide organization which has as its object the promotion of the academic study of the history of religions through the international collaboration of all scholars whose research has a bearing on the subject.

ARTICLE 2

The IAHR seeks to achieve this object:

(a) by holding regular international congresses and occasional symposia and colloquia;

(b) by put ishing the proceedings of such congresses and meetings;

 (c) by assisting the formation of national and regional associations of historians of religions;
 (d) by ancouraging and sponsoring publications of general interest to the study of (d).

(d) by encouraging and sponsoring publications of general interest to the study of the history of religions: e.g. an international review, bibliographical bulletins, monograph series;

(e) by taking all appropriate steps to encourage and further the academic study of the history of religions.

ARTICLE 3,

The IAHR is constituted by national or multi-national (regional) societies for the academic study of religions. These are such societies as are now members and such societies as apply for membership and, on recommendation of the Executive and International Committees (see below), may be admitted by the General Assembly at future International Congresses.

ARTICLE 3B

To the IAHR may be affiliated.

 (a) International associations for the academic study of particular areas within the history of religions;

(b) Individual scholars for whom there is no appropriate national or regional society.

Affiliation is effected by the application to the Executive and International Committees and by approval of the General Assembly.

ARTICLE 4

The work of the IAHR is carried out through (a) the General Assembly; (b) the International Committee: and (c) the Executive Committee.

(a) The General Assembly of the Association meets at each international congress and is composed of all members of constituent societies of the association present at that congress. The General Assembly may take action only on matters referred to it from the International Committee, and it may refer any matter to the International or Executive Committees for consideration and report

(b) The International Committee is composed of:

 (i) Two representatives each of the constituent national and regional societies, except that there shall not be more than two representatives from any one country;

(ii) The Executive Committee (see below);

(iii) Up to four individual members co-opted by the International Committee on the recommendation of the Executive Committee;

and the members of the Executive Committee in general, shall be chosen in such a way as reasonably to reflect various parts of the world where academic study of subject to re-election, but not more than two-thirds of the Committee shall be carried than one month prior to each international congress. The International Committee, religion is pursued in its various disciplines. A Nominating Committee, appointed of members of the Executive Committee, until the next quinquennial congress. the remaining officials, and shall serve, subject to the written approval of a majority of the Association, a suitable replacement may be nominated after consultation among more than two terms. In the event of the death or resignation of any serving officer on from one term to the next, and no one member shall serve in the same office the Executive Committee shall hold office for one quinquennial term each and be and shall report this to the General Assembly for endorsement. The members of at its meeting just preceding the General Assembly, shall elect the Executive Committee Members of the International Committee may propose alternate nominations not less twelve months and not less than nine months prior to each international congress. Committee to the members of the International Committee by mail not more than by the Executive Committee, shall submit nominations for the next Executive General Secretary, a Treasurer, and five other members. The officers in particular, (c) The Executive Committee is composed of a President, two Vice-Presidents, a

ARTICLE 5

The Executive Committee, or at least the President, General Secretary and Treasurer of the Association shall, if possible, meet at least once a year for the transaction of such necessary business as may arise between congresses. The General Secretary shall circulate the minutes of such meetings to all members of the Executive Committee.

ARTICLE 6

The International Committee shall meet on the occasion of each congress, between the meeting of the Executive Committee and that of the General Assembly, and more often if necessary. It reports to the General Assembly.

ARTICLE 7

The resources of the IAHR consist of:

(a) annual contributions paid by the constituent societies, affiliated societies and individual members, the amount of which is assessed by the Executive Committee; and

(b) grants, donations and other sources of revenue.

An audited report will be submitted to the International Committee at every international congress.

ARTICLE 8

The Constitution may be modified only by the General Assembly on the recommendation of the International Committee.

NOTE ON MEMBERSHIP

A person is automatically a member of the International Association if that person belongs to one or another of the national organizations that constitute the International Association or, where no such national organization exists, that person has been awarded individual membership.
