#### CISR/ICSR conference

The next meeting of the "International Conference for the Sociology of Religion" (ICSR) will be held at Helsinki in 1989 (August 21-25). The following text is drawn from the ICSR Bulletin:

"Helsinki will welcome us for the XXth Conference. We intend that it should both cause a stir and serve as a stimulus to new impulses in our discipline. To this end, James BECKFORD will produce a Trend report on the evolution of the sociology of religion (1945-1989) and Emile POULAT will appraise the contribution of the ICSR to the scientific discussion of religion (1948-1988). With regard to the theme, this has been outlined by the local committee (president Nils G. HOLM), discussed by the GA and may now very provisionally be set out as follows:

### Religion in the public sphere: individualization and politization.

Your opinions and proposals concerning the theme, the possible sub-themes, the authors of the papers in plenary sessions, the organization of the latter, are all welcome. Please send them to the general secretariat before 31st December 1987. You will, in so doing, stimulate the imagination of the Council that will meet at the beginning of 1988. The March Bulletin will give you information about the decisions that will be then have been made and the possible contributions of the members of the ICSR. The success of the XXth Conference thus depends on the rapidity of your reactions and on the dynamism that they engender."

#### Conference notice

ESOTERIC BUDDHISM IN JAPAN
-Its Influence on Japanese Culture, Past and Present-

A Two-Day Seminar to be held at the University of Aarhus, Denmark, mid-September 1988, under the auspices of The Seminar for Buddhist Studies Copenhagen and Aarhus.

The Danish Association for the History of Religions (DAHR, affiliated to the IAHR)

At the above-named seminar, to be held in Aarhus, Denmark, on or about the 15th September 1988, we hope to cast some light on the position of Vajrayana Buddhism in Japan, a major Buddhist tradition which unfortunately has been relatively neglected in the West. The Japanese Shingon Sect will form the focus of the Seminar, being the only sect which regards itself as completely esoteric. It is, however, also our intention to examine the esoteric elements in the influential and to some extent rival- Tendai Sect, as well as the appearance of esoteric Buddhist teachings and practices on the popular level of Japanese religion. At the moment, we envisage holding four sessions, roughly as follows:

Day One: Introduction to the History and Philosophy of the Sino-Japanese Vajrayana (Ian Astley, Aarhus)

Day Two: Japanese Esoteric Buddhist Art (Roger Goepper, Cologne) Esoteric Elements in Japanese Mountain Religion (Ian Reader, Hirakata, Osaka)

There will be facilities for showing slides or using other audio-visual media, and ample time in the respective sessions for making full use of these facilities. Since the ritual and the art of this tradition lend themselves to such representation, contributors are encouraged to avail themselves of this opportunity.

We are planning to publish the seminar papers in our journal, Studies in Central and East Asian Religions, about which information is available on request.

#### Traditional Cosmology Society

The <u>Traditional Cosmology Society</u> was founded in Edinburgh, U.K., in 1984 for the international study of myth, religion and cosmology. It aims to provide a forum for discussion and to promote interdisciplinary exchange. Scholars from many disciplines contribute to its conferences, talks and publications: Religious Studies, Social Anthropology, History and Philosophy of Science, Hebrew, Sanskrit, Literature, Archaeology and ohter areas of study and research are all well represented.

A regular programme of lectures and conferences is held, and two publications are produced. Meetings are held mainly in Scotland and it is anticipated that for those living outside Scotland publications will be of most interest. Members receive annually a yearbook, Cosmos, and two issues of newsletter, Shadow. Both are substantial publications and include in the form of articles a large number of the papers given at conferences or as individual lectures in the Society's programme. Book notices and news are also included in the newsletter. The yearbook is on the theme of the preceding year's summer conference, and the 1987 issue of the yearbook is on Analogy.

The subscription year runs from 1st January, and the rates are: Individual £7.50; Joint (two members at the same address receiving only one copy of the publications) £10; Student (receiving only the newsletter) £3; Institutional £12. Overseas members should add £2 to these rates.

It is hoped that IAHR members will be interested in joining the Society, which already has good relations with the BAHR. Those who are likely to visit Scotland may also whish to write for a current programme of lectures and conferences.

# Traditional Cosmology Society CONFERENCE ON POLYTHEISTIC SYSTEMS

Edinburgh, Scotland 8th-13th August, 1988

The Traditional Cosmology Society was established in 1984 for the international and interdisciplinary study of myth, religion and cosmology. The Society's main summer conference is fast becoming recognised as a major event for scholars whose interests lie in these areas. In August 1988 a wide-ranging programme of papers and forums on the broad theme of Polytheistic Systems will be presented at Pollock Halls, University of Edinburgh. Many of the papers will thereafter be published in Cosmos, no. 5, the 1989 issue of the Society's yearbook.

A number of offers of papers have already been made by eminent scholars in the field, dealing with the question of polytheism in relation to Hinduism, African religions, the Old Testament, Aztec and Huichol religion and others, as well as papers covering theoretical aspects of the evaluation of polytheistic systems.

The Edinburgh International Festival (one of the largest arts festivals in the world) will be taking place in the second half of August and conference participants may wish to take advantage of this opportunity to stay in Edinburgh a little longer. #### Français:

Depuis plus de vingt ans, la section de l'École Française d'Extrême-Orient de Kyōto est un centre de travail pour les chercheurs européens et japonais et un carrefour de rencontre pour les Orientalistes de tous les pays.

C'est le besoin d'offrir à nos diverses activités une expression plus cohérente qui a donné naissance aux *Cahiers d'Extrême-Asie*. Dans cette revue nous diffuserons de manière rapide des informations de recherche que nos multiples affiliations et notre situation géographique privilégiée nous permettent de réunir.

La majorité des membres du secteur Chine-Japon de l'EFEO s'est réunie pour former le Comité de rédaction de nos *Cahiers*. Certains présenteront, dans les numéros suivants, des rapports sur la recherche dans leurs domaines respectifs (études de Dunhuang, taoïsme, études bouddhiques, iconographie).

La formule bilingue des *Cahiers d'Extrême-Asie* exprime notre désir d'intensifier la collaboration entre collègues francophones et anglophones. Avec des bibliographies annotées et des rapports de recherche nous souhaitons stimuler les relations entre chercheurs travaillant en Occident et en Extrême-Asie.

#### English:

The first scholar of the "École Française d'Extrême-Orient" (EFEO) came to Japan in 1902. Since 1964, the China-Japan sector of the EFEO has maintained a Research Center in one of the oldest Zen temples in Kyōto. The scholars working at this Center have created the Cahiers d'Extrême-Asie in order to provide a more widely accessible accounting of their varied activities and to communicate, as rapidly as possible, some of the information their privileged location in Kyöto permits them to collect.

The members of the EFEO China-Japan sector comprise the Editorial Board. Some of them will, in subsequent more topical issues, report on the work of their respective research teams in France and in Japan (CNRS Dunhuang Research Group, EFEO Taoist studies, Paris; EFEO Hōbōgirin Project, Kyōto).

The bilingual policy of the Cahiers d'Extrême-Asie expresses our wish to enhance cooperation between French and Anglo-Saxon colleagues. With bibliographies and research reports in all issues we hope to stimulate communication between scholars working in East Asia and those in the West.
